## **SWEARING IN CEREMONIES**

### **COUNCIL MEMBERS**

On January 4, 2010, at 7:45PM, just prior to the Council meeting, District Magisterial Justice Fred Miller administered oaths of office to re-elected and newly elected Council members William Latchford, Christy Ray, Courtney Rhoades and William Fink, all of whom were elected in November, 2009. The sworn in members assumed their seats on Borough Council.

The Organization and Work Session of the Tyrone Borough Council was called to order at 8:00PM at the Municipal Building, 1100 Logan Avenue, Tyrone, PA. Mayor Fink led the group in the Pledge of Allegiance and Pastor Norm Huff gave the Invocation.

### **CALL TO ORDER**

Mayor Fink called the meeting to order and requested roll call. ## **ORGANIZATION OF BOROUGH COUNCIL**

### **ELECTION OF VICE PRESIDENT OF COUNCIL**

It was moved and seconded that William Latchford retain his seat as Vice President of Council. A roll call vote was taken. Ayes: Council members Bryan, Hanzir, Kosoglow, Ray, Rhoades, Stoner and Mayor Fink. Council member Latchford abstained.

### **DESIGNATE TIME AND PLACE OF COUNCIL MEETINGS**

Council member Ray inquired as to the necessity for two monthly meetings. Mrs. Ray feels that if Council meets, discusses and votes all in the same night that more residents may attend the meetings. Council member Stoner explained the reason behind the two meetings. Mrs. Ray also suggested that Council pick up their Council packets or have them emailed. Not all Council members were in favor of having their packets emailed. Solicitor Clapper confirmed that the Borough's Home Rule Charter requires one monthly meeting.
