## ORDINANCE NO. 1178

AN ORDINANCE OF THE BOROUGH OF TYRONE, A HOME RULE MUNICIPALITY, PROHIBITING PARKING ON THE NORTH SIDE OF TENTH STREET FROM LOGAN AVENUE TO PENNSYLVANIA AVENUE BETWEEN THE HOURS OF 6:00 A.M. TO 8:00 A.M. EVERYDAY FROM NOVEMBER 15 THROUGH MARCH 15 AND ON WEDNESDAY AND FRIDAY ONLY FROM MARCH 16 THROUGH NOVEMBER 14, AND ALLOWING FIFTEEN (15) MINUTE PARKING BETWEEN THE HOURS OF 6:00 A.M. TO 8:00 A.M. YEAR ROUND ON THE SOUTH SIDE OF TENTH STREET FROM LOGAN AVENUE TO BERLIN STREET; AND ESTABLISHING AN EFFECTIVE DATE.

The Borough of Tyrone hereby ordains the following:

## SECTION 1. PARKING PROHIBITED DURING CERTAIN HOURS.

No person shall park a vehicle or allow the same to remain parked upon any of the streets or parts of streets described below, between the hours specified as indicated below.

Name of Street	Between	Prohibited Hours	<u>Dates</u>
Tenth Street (North Side)	Logan Avenue to Pennsylvania Avenue	6:00 a.m. to 8:00 a.m.	November 15 through March 15 - every day. March 16 through November 14 - Wednesdays and Fridays.
Tenth Street (South Side)	Logan Avenue to Berlin Street	15 minutes parking allowed only from 6:00 a.m. to 8:00 a.m.	Year round.

## SECTION 2. AUTHORIZATION TO ERECT TRAFFIC SIGNS.

The Borough of Tyrone may erect signs at the appropriate places to advise those traveling said streets of the provisions provided herein.

## SECTION 3. PENALTIES.

Any person, partnership or corporation who or which shall violate any of the provisions of this Ordinance shall, upon conviction thereof, be sentenced to pay a fine of not more than Twenty-five (\$25.00) Dollars and costs of prosecution or, in default of payment of such fine and costs, to undergo imprisonment for not more than five (5) days; provided, however, that each violation of any provision of

this section and each day the same is continued and shall be a separate offense.

SECTION 4 SEVERABILITY.

If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Borough Council of the Borough of Tyrone that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part

SECTION 5. REPEALER.

thereof not been included herein.

Any Ordinance or Resolution or parts thereof inconsistent with the terms of this Ordinance are hereby repealed. Specifically, Ordinance 1131 is hereby amended as denoted in Section 1 hereof by the underlining of added language.

SECTION 6. EFFECTIVE DATE.

This Ordinance shall become effective at the earliest possible date provided by law.
