SECTION 6. PENALTY FOR VIOLATION.

1. If at any time during a period of snow emergency declared under Section 2 and/or a snow accumulation of three (3) or more inches as set forth under Section 3 of this Ordinance, a person shall park a motor vehicle or allow a motor vehicle to remain parked anywhere upon a snow emergency route, and/or is in violation of Section 3, that person shall be guilty of a violation of this ordinance, and, upon conviction, shall be sentenced to pay a fine of not less than Fifty Dollars (\$50.00) nor more than One Hundred Dollars (\$100.00) plus costs.

2. If, at any time during a period of snow emergency declared under Section 2 of this Ordinance, a person shall drive a motor vehicle upon a snow emergency route, without having that vehicle equipped with snow tires or chains, that person shall be guilty of a violation of this Ordinance, and, upon conviction, shall be sentenced to pay a fine of not less than Fifty dollars (\$50.00), nor more than One Hundred dollars (\$100.00), plus costs.

SECTION 7. <u>REPEALER.</u>

Any Ordinance or parts of ordinances inconsistent with the provisions of this Ordinance are hereby

repealed insofar as the same conflicts with this Ordinance.

SECTION 8. EFFECTIVE DATE.

This ordinance shall become effective upon publication in accordance with Section 509 of the Home Rule Charter.

SECTION 9. <u>SEVERABILITY</u>.

If any sentence, clause, section or part of this Ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses, sections or parts of this Ordinance. It is hereby declared as the intent of the Borough Council of the Borough of Tyrone that this Ordinance would have been adopted had such unconstitutional, illegal or invalid sentence, clause, section or part thereof not been included herein.
